



- Final Payment Certificate last payment to complete payment for one or more Sections Of Works
- Customs Payment Certificate In some countries, Customs & Import Duties need to be calculated separated and claimed for via their own payment certificates
- Certificate Attachment Generated along with each Payment Certificate, this attachment shows detailed payment status for all Sections Of Works
- Subsection Attachment drilldown into the payment status of the subsections of a single Section of Works
- Customs Attachment Lists individual Customs payments
- Variation Order Attachment Unified view of changes to the contract pricing after a Variation Order
